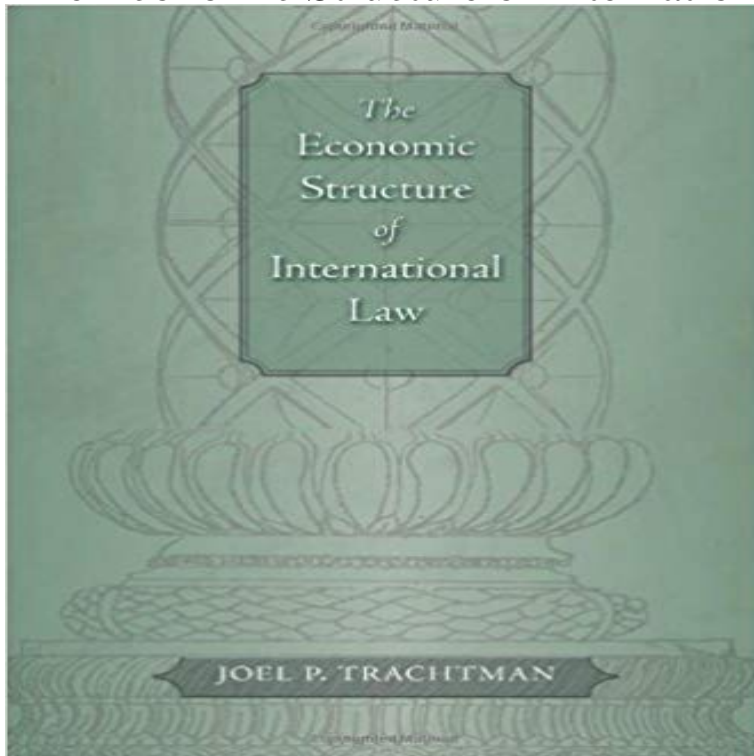


The Economic Structure of International Law
